Subject: Renewal of California's Five-Year Section 1115 Waiver: Medi-Cal 2020

Dear Administrator Slavitt:

Sonoma Valley Health Care District, dba Sonoma Valley Hospital, is pleased to support the application recently submitted by California for the 5-year Section 1115 Medi-Cal Waiver, Medi-Cal 2020.

California proposes to build on the successes of the 2010 waiver, The Bridge to Reform, with a goal of expanding and improving the Medi-Cal program through delivery and payment system transformation. These improvements include strengthening access to primary care; avoiding unnecessary hospitalizations, implementing integrated health care delivery systems and providing incentives for meeting the Triple Aim.

The Medi-Cal 2020 proposal allows for continued delivery system transformation in California, and expands the program to more areas of the state by including public district/municipal hospitals. Sonoma Valley Hospital is eager to participate in the proposed system transformation, which will allow public district/municipal hospitals to bridge the gap between traditional health care and the health care system of the future based on each community's needs.

Sonoma Valley Hospital agrees with all stakeholders that health care systems must evolve to better meet the needs of patients, our communities, payers and other providers. Examples of the types of projects Sonoma Valley Hospital would like to implement include:

- Building a Community Care Network of health coaches and providers/provider agencies that will allow for care management for moderate to high risk community members in an effort to improve population health and reduce ED overutilization and re-admissions.
- Building a complex care management program for targeted populations focused on disease reversal and quality of life.
- Partnering with the local Community Health Center and California Partnership to identify and mutually care manage at risk Hispanic, low income and populations needing access to healthcare and outpatient services in a more integrated fashion.

California's 2010 Section 1115 waiver was essential in supporting California's successful implementation of the Affordable Care Act (ACA). The Centers for Medicare & Medicaid



Services' (CMS) approval of the Medi-Cal 2020 waiver is critical as allows the state's non-designated public hospitals, such as Sonoma Valley Hospital which serve many low-income Californians and due to challenges related to location and other issues, need the assistance to appropriately begin the transformation process to better meet the needs of patients and residents.

We strongly support the approval of California's Medi-Cal 2020 proposal and we look forward to working stakeholders on its implementation. We also appreciate the California Department of Health Care Services' ongoing commitment and efforts to the Medi-Cal program to the benefit of all Californians.
